Executive Summary

Introduction

The following report has been prepared by Professor Kenya Covington, Chair of the Diversity Education Governance Committee (DEGC), and Dr. Julia Nelsen, Principal Policy Analyst, in collaboration with Claire McCluskey (Deputy Registrar) and the members of DEGC. It is intended to provide the Undergraduate Council with an analysis and overview of UCLA's progress-to-date in implementing and administering a Diversity Requirement (DR) for undergraduates in the College of Letters and Science (College). It summarizes historical materials, curricular information, and data collected from Fall 2015 to Winter 2023, in the following areas:

- Administration of the Diversity Requirement.
- The number of DR courses approved by the Diversity Education Governance Committee and its predecessors, as well as information on the departments and divisions offering DR courses.
- Student enrollment in DR courses.
- Information on DR course instructors.

Accomplishments to Date

Since its establishment in 2018 as a standing committee of the Academic Senate to define the values and purposes of diversity education at UCLA, the Diversity Education Governance Committee (DEGC) has achieved the following:

- Approved 64 courses for DR credit.
- Revised criteria and learning outcomes for DR courses.
- Issued policy guidance for variable topics courses proposed to fulfill the College DR.

Recommendations

After careful analysis of the data related to course offerings, enrollment, student experiences, instructor demographics, and the administration of the DR, DEGC recommends the following:

- Consolidation of DR course requirements, submission guidelines, approval process under DEGC.
- Development of additional DR courses, particularly in south campus.
- Assessment of student learning outcomes and experiences in DR courses.
- Evaluation of instructor experiences; enhanced training and workshops for faculty and TAs teaching DR courses.

History of the Diversity Requirement at UCLA

2007

The School of Arts and Architecture (SoAA) was the first at UCLA to establish a Diversity Requirement for the Bachelor of Arts Degree. As outlined in the <u>original proposal</u>, the requirement was intended to enhance students' understanding of the "multicultural, transnational, global nature" of the arts and the "social context and cultural grounds of artistic production, reception and consumption."

Following approval by the SoAA faculty in December 2006, the Undergraduate Council voted unanimously on February 16, 2007 to approve the revisions to Academic Senate Regulation 436 A-F establishing a Diversity Requirement in the School. The Legislative Assembly approved the revised regulation on April 30, 2007. The SoAA Diversity Requirement became effective for all new undergraduate students in the School beginning with the entering class of Fall 2007.

2013-14

In response to renewed campus interest in diversity, equity, and inclusion with the launch of UCLA's Principles of Community in 2010, Christina Palmer, then Chair of the College Faculty Executive Committee (FEC), formed the College Diversity Initiative Committee (CDIC) in Winter 2014. The charge of this committee, co-chaired by Professor Michael Alfaro and Professor Belinda Tucker, was to develop a proposal for a Diversity Requirement for undergraduates in the College of Letters and Science.

CDIC developed the <u>proposal</u> in consultation with College faculty, administrators, and a student advisory group. The committee also researched empirical evidence and educational best practices, as well as comparable requirements at peer institutions, to establish course criteria and learning goals for the College Diversity Requirement at UCLA.

Following approval by the College FEC in May 2014, the Undergraduate Council (UgC) voted unanimously in favor of the proposed College Diversity Requirement on June 16, 2014.

2014-15

Following UgC approval of the proposal, the College FEC Chair convened an *ad hoc* Diversity Initiative Implementation Committee to assess the feasibility of launching the requirement for incoming students in Fall 2015. The *ad hoc* committee also articulated a review and evaluation process for courses proposed to fulfill the diversity requirement. In September 2014, the *ad hoc* Implementation Committee issued a detailed report summarizing its findings and recommendations.

2015

The Diversity Requirement (DR) for the College of Letters and Science was passed in April 2015 after an all-campus vote of Senate faculty. Starting in Fall 2015, all incoming first-year students were required to fulfill the requirement, Transfer students were held to the requirement beginning in Fall 2017.

2015-17

From 2015-2017, the Undergraduate Council appointed an *ad hoc* Diversity Requirement Committee to review and recommend courses to the UgC for fulfillment of the College Diversity Requirement. The *ad hoc* committee also advised faculty on how to adapt existing courses to fit DR criteria, and developed recommendations to UgC for a permanent Academic Senate body to oversee the College Diversity Requirement.

The Herb Alpert School of Music instituted a diversity requirement for its undergraduate students upon the School's formation in 2016.

2017-18

In June 2017, the Undergraduate Council unanimously approved an amendment to Academic Senate Appendix XIII that made permanent the *ad hoc* Diversity Requirement Committee as a committee appointed annually by the UgC's Administrative Committee. On November 30, 2017, the Legislative Assembly approved the bylaw amendment formalizing the <u>Diversity Education Governance Committee</u> (<u>DEGC</u>). Since Fall 2018, DEGC has convened quarterly to review and recommend DR courses to UgC, and to advise the Council and the Dean of Undergraduate Education on all matters pertaining to the Diversity curriculum.

2018 - present

In 2018, the Luskin School of Public Affairs instituted an undergraduate diversity requirement as part of its B.A. in Public Affairs. In 2020, the School of Education and Information Studies established a diversity requirement for undergraduate students within the B.A. in Education and Social Transformation. The Fielding School of Public Health will require undergraduates in the B.A. and B.S. in Public Health to complete a diversity requirement, effective Fall 2023. While the majority of students graduating from UCLA with a Bachelor's degree are required to complete a Diversity Requirement, the Schools of Engineering, Nursing, and Theater, Film and Television do not presently have a DR for their undergraduate majors.

In Winter 2022, the Diversity Education Governance Committee and the Undergraduate Council approved revisions to the Diversity Course Information Sheet and submission guidelines to incorporate student-centered educational goals and learning outcomes for DR courses.

Assessment of the College Diversity Requirement: Summary of Data and Findings

Approved Courses

As of Winter quarter 2023, a total of 673 courses are approved to fulfill the Diversity Requirement (DR) across UCLA as a whole.

398 of the total courses fulfill the DR for the College of Letters and Science. Of these, 306 courses exclusively fulfill the College DR, while ninety-two courses satisfy the requirement for both SoAA and the College. SoAA continues to maintain its own list of DR courses approved by the School's Faculty Executive Committee. Schools which adopted a Diversity Requirement after 2015 utilize the College list of courses approved by the Diversity Education Governance Committee.

Among the 398 courses that fulfill the College DR, seventeen are year-long courses in the Cluster Program (generally reserved for freshmen) and 381 are quarter-long courses. 168 courses are multiple-listed across two or more departments. Diversity courses are offered in a variety of formats, from lecture classes to discussion-based seminars and experiential learning courses. Numerous Diversity courses also satisfy other academic requirements for the Bachelor's degree (e.g. General Education, Writing II).

The current total of College DR courses (398) represents an over 600% increase since the requirement first took effect in Fall 2015, when 55 courses were initially recommended to fulfill the DR. From Fall 2015 to 2017, the Undergraduate Council's *ad hoc* Diversity Requirement Committee approved a total of 187 courses. Since its establishment in Fall 2018, DEGC has approved a total of 64 courses.

For the course numbers and titles of all courses approved to fulfill the College Diversity Requirement, see Appendix A.

Diversity Requirement Courses in the College of Letters and Science




Figure 1: Distribution of courses approved to fulfill College DR - by Division

Diversity courses vary in distribution across the University (see Fig. 1 below), with the vast majority housed in the Social Science and Humanities divisions of the College.

- Of the 171 DR courses in the Social Sciences, the department of History offers the most (43).
 Ethnic studies disciplines house 54 courses in total, across the African American, American
 Indian, Asian American, Chicana/o and Central American Studies Departments. Anthropology,
 Labor Studies, and Sociology offer roughly a dozen courses each. Less represented are the
 departments of Communication (5 courses) and Political Science (4 courses). Economics and
 Geography offer only one Diversity course each.
- Ninety-three DR courses are in the Humanities. The majority are offered by the Departments of Near Eastern Languages and Cultures (20), Asian Languages and Cultures and European

Languages and Transcultural Studies (10 each), and English and Comparative Literature (19 total).

- Ten courses in the International Institute satisfy the DR, encompassing Global Studies, International and Area Studies, Global Health and International Development Studies.
- The divisions of Life Sciences and Physical Sciences offer a total of thirty-four Diversity courses.
 Eleven of the approved courses in the Life Sciences are in Psychology, while eight are housed in the Institute of Society and Genetics. A total of ten courses address topics in the biological sciences and biomedical research. Three courses in the Physical Sciences fulfill Diversity, in the Departments of Earth, Planetary and Space Sciences and Statistics.

With the exception of Engineering, Nursing, and Management, the professional schools also house a number of courses that fulfill the College DR, as outlined below:

- The Herb Alpert School of Music offers L&S-approved Diversity courses in the Departments of Ethnomusicology (6), Global Jazz Studies (4), and Musicology (7).
- The Department of Education, which houses the B.A. in Education and Social Transformation within the School of Education and Information Studies, offers seven courses.
- In the Luskin School of Public Affairs, six DR courses sit within the schoolwide B.A. in Public Affairs. All other departments in the School have Diversity courses, with the exception of Public Policy. Topics span from environmental justice, to diversity in aging, to urban planning in a multiethnic and global context.
- The School of Public Health offers three courses on the L&S Diversity list with a focus on community health sciences and epidemiology.
- Theater, Film and Television houses two courses.

Diversity Courses as a Percentage of Catalog Offerings

Overall, DR courses represent five percent of total courses in the College catalog. Appendix B outlines DR courses as a percentage of the catalog, by division and department, illustrating the concentration of the requirement within departmental offerings and relative to the size of departments.

- In the Social Sciences, ten percent of courses satisfy the DR. Gender Studies has the highest concentration of Diversity courses, representing 23% of the department's catalog offerings. In ethnic studies departments, DR courses represent between 11% and 19% of the catalog. Diversity courses constitute 13% of the catalog for History and 11% for Sociology. Among smaller programs, Labor Studies stands out with 13% of its courses satisfying the DR.
- Four percent of courses in the Humanities catalog fulfill the Diversity requirement. Individual departments in the Humanities division each offer less than ten percent of DR in the catalog, ranging from Comparative Literature (8%) to Linguistics (5%) to Classics (2%). An exception is the Center for the Study of Religion, where DR courses comprise 16% of courses in the catalog.
- DR courses represent five percent of the catalog in the Life Sciences. In the Institute of Society
 and Genetics, 15% of offerings fulfill the DR, followed by the department of Psychology with 7%.
 One percent of courses in the Physical Science division satisfy the DR.

 Among interdisciplinary programs in the College, the Cluster Program is a particularly notable source of DR courses representing 40% of the catalog. Fourteen percent of courses offered by the Center for Community Engagement fulfill the DR.

Course Enrollments

Since the College Diversity requirement was established in 2015, through Fall 2023, a total of 170,667 students have enrolled in DR courses. Students may satisfy the College DR either through courses offered on campus, or through approved transfer courses offered by another institution.





Figure 2: Week 3 Enrollment vs. Enrollment Caps for College DR course offerings

When the College DR was first proposed in 2015, the <u>resource analysis from the Office of Academic Planning and Budget</u> indicated that "there will indeed be sufficient, sustained capacity in the future (at equilibrium) to ensure that demand for enrollment to meet the requirement can be absorbed by the system without generating excessive strain either for the course system itself... or for the students who must meet the requirement." Enrollment data (Fig. 2) confirms that student demand is not exceeding the supply of Diversity courses. Most transfer admits enter UCLA having already fulfilled the requirement through previous coursework, as shown in Figs. 3 and 4. DEGC and its predecessor have certified and approved enough DR courses to meet student need. Currently there appears to be an adequate number of seats available in Diversity courses and appropriate policies in place to ensure that students are able to complete the requirement in a timely manner.

Moreover, there is no evidence to suggest that the DR imposes any additional strain on students' time-to-degree. Based on the data summarized in Fig. 5 of students admitted as freshmen between Fall 2019 and Fall 2022, over 3,000 completed a Diversity course during their first year on campus, with most fulfilling the requirement before the end of their third year. The data also indicate that, among students expected to graduate in AY 2022-23, most satisfied the requirement in their first year. The same trend applies to students admitted in subsequent years. Only a small fraction of students from this population took more than one Diversity course, when filtering out any transfer coursework.

Students whose major divisions offer few or no Diversity courses have a substantial number of opportunities to fulfill the requirement through offerings elsewhere on campus. The "heat map" in Appendix C illustrates the concentration of Diversity courses by Division. Humanities and Social Sciences courses have been the principal vehicles through which students in the College have satisfied their Diversity requirement. For example, the Humanities, Social Sciences and L&S Cluster Program furnish an ample supply of courses for students majoring in the Life Sciences. Popular courses used to fulfill Diversity generally correspond with large lower-division courses taken in a student's first years at UCLA (e.g., English Composition 3D, Film and Television 4, and many courses in the Cluster Program).

Summary

The following table summarizes the numbers of College Diversity Requirement courses that have been approved and offered, as well their total student enrollments, from 2015 to 2023:

Student Experience

UCLA Senior Survey

Evaluation of students' experience in Diversity courses has so far been limited to the annual UCLA Senior Survey administered by the Center for Educational Assessment. In the spring quarters of 2019 and 2020, the survey was administered to graduating seniors in the College and schools with a Diversity Requirement.






Figure 6: Summary of responses to Diversity questions - 2019 UCLA Senior Survey

The 2019 survey included a bank of questions specific to the Diversity Requirement (in addition to general diversity and campus climate-related questions). Students were asked if they completed the requirement with a course taken at UCLA. Questions also addressed to what extent the Diversity course(s) met the educational goals of the requirement and helped students understand and engage with issues of cultural and societal difference. (See Fig. 6.) In 2020, the survey asked two questions about how the Diversity Requirement helped students think more broadly about an issue and recognize the biases that affect their thinking.

The 2019 and 2020 Senior Surveys are the primary source of an evaluation of student experiences with DR courses on campus. An in-depth assessment of student experiences with individual courses will likely offer additional insights. In an effort to better understand the student experience in Diversity classes, further qualitative data may be gathered from the Evaluation of Course Instruction forms to assess the extent to which students feel that their courses and instructors are achieving the aims of the Diversity Requirement.

DR Course Instructors








Figures 7 and 8: Instructor appointment types for College DR courses and total instructors of College DR courses, 2015-2022.

When the College Diversity Requirement was established in 2015, ladder-rank faculty represented the majority of DR course instructors. Since then, the percentage of non-ladder faculty teaching DR courses has steadily increased, peaking in AY 2020-21. This data is consistent with broader UC-wide trends of non-tenure-track faculty and TAs teaching more courses, particularly lower-division courses with high enrollment. (See Figs. 7 and 8.) The imbalance is not large, however, and the data indicates a near split, with ladder rank just under 50%. Moreover, DR courses generally are not core courses which ladder-rank faculty typically teach. Thus, ladder faculty may have fewer opportunities to develop innovative courses focused on Diversity in their fields.

Of all instructors who have ever taught a Diversity course in the College, the majority are female non-ladder faculty (741), followed by female ladder faculty (627). Male ladder faculty have taught a lower percentage of Diversity courses overall since 2015. In terms of race and ethnicity, among DR instructors, the majority identify as white. (See Figs. 9 and 10.) Further data and analysis are needed to assess whether the composition of DR teaching staff is consistent with general faculty demographics or specific to DR courses.

The 2014 CDIC report recommended that funding be made available to offer training opportunities and resources for faculty and teaching assistants seeking to learn more about pedagogical best practices for engaging diversity-related themes in the classroom. At the time, reports from town halls indicated that existing training did not consistently include strategies for effective teaching on diversity topics. Further systematic assessment of teaching experiences may assist DEGC in understanding and addressing the challenges instructors may face with planning courses, preparing assignments, and evaluating student work in alignment with Diversity criteria.

Recommendations and Issues for Further Consideration

Echoing the 2014 CDIC report, DEGC reaffirms that "a diversity requirement should be more than a list of courses – it should be part of a cohesive approach to the value of diversity in education." Moreover, a robust Diversity curriculum can help equip students to succeed and become leaders in an increasingly pluralistic and multicultural world, in alignment with the University's public-facing mission.

In order to strengthen UCLA's Diversity curriculum and effectively fulfill the committee's charge, DEGC has identified the priorities and recommendations outlined below.

Administration of the Diversity Requirement

As a standing committee of the Academic Senate, DEGC is charged with advising the Undergraduate Council and the Dean of Undergraduate Education on all matters pertaining to Diversity Education at UCLA. The following recommendations are intended to streamline the management and administration of the DR:

- 1. Course approval process. Since the Diversity Requirement in the School of Arts and Architecture predated the College DR, SoAA has historically maintained its own list of courses approved by the School's Faculty Executive Committee, not all of which fulfill the College DR. To ensure consistency and uniformity in the approval and tracking of Diversity Requirement courses going forward, we recommend consolidating the College and School lists and establishing a single master list of courses approved to fulfill DR credit for the University. We also recommend that the Undergraduate Council issue a communication to all Faculty Executive Committees affirming Academic Senate oversight of the Diversity Requirement, in line with DEGC's charge to review and recommend to the Council courses submitted by the College and professional school Faculty Executive Committees to satisfy the DR.
- 2. Recertification of approved courses. To date, courses previously approved for DR credit have not undergone recertification. To bring courses into alignment with the revised goals and learning outcomes issued by DEGC in 2022, the committee recommends developing a procedure and timeline to re-certify previously approved DR courses approximately every five years, akin to the recertification process for General Education courses.

3. **DEGC Membership.** We recommend that the Undergraduate Council's Administrative Committee appoint future DEGC members from the School of Arts and Architecture and other schools that admit undergraduate students, in order to foster campuswide engagement with the Diversity Requirement and to ensure representation on the committee from a broad range of disciplinary areas and academic units.

Course Development and Outreach

Currently, UCLA is broadly equipped to meet student demand for DR courses. Enrollment data show that there is an adequate number of course offerings and seats available to ensure that students in the College are able to complete the requirement without increasing time-to-degree. However, existing capacity is unevenly distributed across divisions and disciplines. To enhance the Diversity curriculum across the University, DEGC recommends the following:

- Incentivize the development of Diversity courses across disciplines. The overall distribution of courses currently approved to fulfill the DR suggests a heavy concentration of the requirement in disciplinary areas that already tend to engage with topics of diversity, race and ethnicity, class, gender, and intercultural dynamics. Additional capacity may help students connect with DR courses within their chosen fields of study. Students may experience an added benefit in aligning and integrating discussions of diversity with their academic interests and goals. To ensure commonality across students' educational experiences, DEGC encourages broad engagement with the Diversity Requirement among all academic units on campus. There are opportunities to expand the breadth of DR courses in the College and professional schools, particularly in STEM fields. The recently established undergraduate majors in Public Affairs and Public Health also offer new opportunities to examine wide-ranging policy issues through diverse racial, ethnic, social and cultural lenses. DEGC recommends that resources be allocated to incentivize the development of new Diversity courses spanning north and south campus, including new teamtaught interdisciplinary classes and community-engaged courses.
- 2. Solicit course proposals for the DR. Since its establishment in Fall 2018, DEGC has reviewed and approved a total of 64 DR course proposals. This marks a decrease from the volume of course proposals reviewed by the ad hoc committee following the launch of the College DR. The slow rate of influx, particularly in recent years, may indicate a saturation of DR offerings or a lack of awareness about the DR among faculty. To raise awareness, DEGC suggests issuing an annual call to all departments soliciting course proposals for DR credit. In addition to encouraging the development of new courses, we recommend that DEGC identify existing courses that could potentially fulfill the Diversity Requirement through a review of course titles and descriptions of all undergraduate courses offered within the past five years, using data provided by the Registrar's Office. Upon gathering this information, DEGC may encourage relevant departments and faculty to submit DR course proposals for evaluation. Outreach is especially encouraged to south campus and to departments that offer few or no DR courses.

Student Experience

In order to gauge how effectively Diversity courses are achieving educational goals and learning outcomes in the classroom, DEGC recommends further qualitative assessment of students' experiences with the DR across disciplines in partnership with the Center for the Advancement of Teaching (CAT) and the newly established UCLA Teaching and Learning Center (TLC). The following areas may be considered for this purpose:

- UCLA Senior Survey. DEGC recommends that the Center for Educational Assessment revise the annual survey to graduating seniors to incorporate a bank of questions specific to the Diversity requirement, akin to the 2019 senior survey.
- 2. Introduce DR-specific questions in course evaluations. We suggest that the Evaluation of Instruction Program (EIP) tailor the Evaluation of Course Instruction forms to include questions on students' experience and learnings in Diversity courses. Initially, such an assessment could be piloted with a subset of representative courses in different subject areas (Humanities/Social Sciences, STEM, and other disciplines). Building on the senior survey, questions could address the degree to which students feel that the course successfully met Diversity aims and learning outcomes through specific content, assignments and assessments. In addition, DEGC seeks to better understand the rationale for students' enrollment in Diversity courses—namely, whether students sought out a particular course explicitly to fulfill the requirement, or whether they would have encountered the DR course as part of their major or minor curriculum.
- 3. Focus groups and interviews. To better understand the impact of the DR on students' worldviews and experiences at UCLA and beyond, we recommend that resources be made available for CAT/TLC to assist DEGC and the Undergraduate Council in undertaking additional qualitative assessment in the form of focus groups or interviews with a representative sampling of current students or graduating seniors who have taken Diversity courses in the past year. Responses may also help DEGC identify additional sources of demand in the DR curriculum.
- 4. Showcasing student research. To recognize and celebrate student projects in DR courses, DEGC recommends that funding be made available to convene a Diversity Research Forum for students to showcase their work and build community across disciplines.

Instructor Experience and Development

To foster effective pedagogy and encourage sustained instructional engagement with diversity inside and outside of the classroom, DEGC underscores the need for further collaboration with the Undergraduate Council and Administration in developing, implementing, and evaluating campuswide training programs and resources for faculty and teaching assistants. In particular, we recommend:

Funding for Diversity-related instructional development. The committee recommends that
resources be made available to CAT/TLC, the Center for Education Innovation and Learning in
the Sciences, and the Office of Faculty Development to augment existing teaching guides,
workshops, TA training, and other resources for instructors to effectively engage with topics of
diversity. We also recommend funding for the development workshops or mentoring resources

that bring together new faculty and TAs with colleagues who have prior experience teaching of Diversity courses.

- 2. Diversity teaching symposium. In order to showcase and celebrate teaching excellence in DR courses, DEGC recommends convening an annual or biennial symposium in partnership with CAT/TLC for UCLA faculty to present best practices, challenges, and strategies for Diversity course development and student engagement. The committee notes that honoraria or award funding should be made available to incentivize faculty participation.
- 3. Offering incentives for ladder-rank faculty to teach Diversity courses. Summer ninths or research funds should be allocated for Senate faculty to develop seminars/courses or to re-tool existing offerings in fulfillment of the requirement. We note that incentivizing teaching by ladder faculty may enhance students' educational experience by allowing for greater opportunities to interact with faculty and to engage with research on topics related to diversity.
- 4. **Instructor surveys and/or focus groups**. DEGC recommends further assessment of the successes and challenges that instructors have experienced in efforts to implement the goals of the Diversity requirement at the course level. This work may be undertaken in collaboration with CAT/TLC through surveys or interviews with faculty and TAs who have taught DR courses.
